


Keynote Address

Dr. Harini Amarasuriya

Prime Minister of the Democratic Socialist Republic of Sri Lanka

Dr. Harini Amarasuriya was sworn in as the 17th Prime Minister of the Democratic Socialist Republic of Sri Lanka on 18 November 2024. She contested the general election held in November 2024



Dr. Harini Amarasuriya was born on 6th March 1970 in Colombo, Sri Lanka. Her multifaceted career spans academia, social activism and grassroots politics, with a focus on youth issues, human rights and social development. She is currently serving the country as a prominent Sri Lankan scholar, social activist and politician.

For the past decade, Dr. Harini Amarasuriya served as a Senior Lecturer in Sociology at the Open University of Sri Lanka. In addition to her teaching responsibilities and the revision of the Sociology curriculum, she was actively involved in administrative leadership roles at the university and has also served as a member of the University Grants Commission's Standing Committee on Gender Equality and Social Equity since 2016. She served as Secretary of the Open University Teachers' Association (2012 and 2013) and Assistant Secretary (2014 and 2015) and Secretary (2016) of the University Teachers' Association, where she campaigned for increased allocations for education in the national budget.

As a researcher, Dr. Harini Amarasuriya has published treatises on elite politics, dissent, social justice, discrimination and youth, female-headed families, child labour, institutionalized child care, early marriage, well-being, educational research and intellectual property. In 2014, Dr. Harini Amarasuriya was the lead author of the National Human Development Report for Sri Lanka and also participated in drafting the National Youth Policy of Sri Lanka that year. In 2016, she also served as a member of the People's Representative Committee (PRC) on Constitutional Reforms of Sri Lanka. Dr. Harini Amarasuriya received her basic education from Bishop's College, Colombo and pursued higher education in several foreign countries. She holds a BA in Sociology from the University of Delhi and a MA in Applied Anthropology and Development Studies from Macquarie University in Sydney, Australia. For that degree, she conducted a research thesis on female migrant workers. In 2011, she wrote her PhD thesis on child protection in Sri Lanka and received PhDs in Social Anthropology and International

Health and Development from the University of Edinburgh and Queen Margaret University.


Dr. Harini Amarasuriya has served for many years as a board member of NEST, a Sri Lankan community health organization; the Center for Women's Research (CENWOR), an organization engaged in research on women's and gender issues in Sri Lanka; and the Law & Society Trust, an organization engaged in legal research, advocacy, and human rights documentation in Sri Lanka.

After the National People's Power Party leader Anura Kumara Dissanayake assumed office as President in the September 2024 presidential election, Dr. Harini Amarasuriya became the 16th Prime Minister of the Democratic Socialist Republic of Sri Lanka and served as the Minister of Women, Children and Youth Affairs and Sports, the Ministry of Justice, Public Administration, Home Affairs, Provincial Councils, Local Government, and Labour, the Ministry of Education, Science and Technology, the Ministry of Trade, Commerce, Food Security, Cooperative Development, Industries and Entrepreneurship Development, and the Ministry of Health. Dr. Harini Amarasuriya is also the Prime Minister of the smallest cabinet in Sri Lanka's history.

Banagoda Arachchilage Kanchana Silan Priyanka Banagoda is a proud product of S. Thomas' College, Bandarawela and Bandarawela Central College. Joining the Sri Lanka Navy on 15th September 1989 as an Officer Cadet of the 19th intake, in the Executive branch, he completed basic training at the Naval and Maritime Academy in Trincomalee. Head of the Training Team at the Defence Services Command and Staff College in Sapugaskanda, Director Naval Training and Acting Director General Training at the Navy Headquarters (NHQ). The senior officer, who has successfully led four naval commands; Southeastern (Panama), North Central (Talaimannar), Northern (Kankesanthurai), and Eastern (Trincomalee), took on the role of Chief of Staff on 16th August 2024. He was appointed as the 26th Commander of the Sri Lanka Navy by His Excellency the President effective from 31st December 2024.

The senior naval officer has been awarded with the Rana Sura Padakkama (RSP), Uththama Sewa Padakkama (USP) and a bunch of other service medals in recognition of his bravery, impeccable character and dedication to the service. Additionally, his efforts have been commended by the Commander of the Navy for successfully apprehending multiple narcotic consignments and three vessels along with their crews during high seas operations conducted by SLNS Sayurala.







Admiral Colombage is a Guest Professor at Sichuan University and a visiting lecturer at Shenzhen University in China. Admiral has conducted lectures to National Defence Colleges, Command and Staff Colleges and universities in Sri Lanka, India and Bangladesh. He has been a guest lecturer at many universities in Sri Lanka, Bangladesh and Indonesia. Admiral has also been an examiner for PhD programme at University of Colombo and Kotelawala Defence University. Admiral has participated in a number of track 1.5 and track 2 dialogues in India, Pakistan, Bangladesh, China, Japan, Germany, Nepal, Turkey and Sri Lanka.

He has served as the Director General of the Institute of National Security Studies Sri Lanka, Director at Centre for Indo-Lanka Initiatives at Pathfinder Foundation and Chairman of Sri Lanka Shipping Corporation as well.

Admiral Colombage was the Additional Secretary to the President for International Relations and Secretary to the Foreign Ministry from August 2020 to May 2022. Admiral Colombage has served as the Ambassador of Sri Lanka to Indonesia and ASEAN until the end of 2024.

Admiral Colombage is a distinguished fellow of Pathfinder Foundation of Sri Lanka and Fellow of Nautical Institute in London.





Adm Dinesh K Tripathi CNS- India

Admiral Dinesh K Tripathi assumed command as the 26th Chief of Naval Staff on 30 Apr 24. Prior to this appointment, he was the Vice Chief of Naval Staff.

He is an alumnus of Sainik School Rewa, and the prestigious National Defence Academy. He was commissioned into the Indian Navy on 01 Jul 1985 and specialised in Communication and Electronic Warfare. His command assignments include command of INS Vinash (Missile Vessel), INS Kirch (Missile Corvette), and INS Trishul (Guided Missile Frigate). Whilst in command of INS Kirch, he played a pivotal role during HADR operations after the Tsunami of Dec 2004, for which he received a letter of appreciation from the then President of Sri Lanka.

His other sea-going appointments include Executive Officer of INS Mumbai (Guided Missile Destroyer), Fleet Electronic Warfare Officer, Fleet Communication Officer as also the Fleet Operations Officer (akin to the Chief of Staff to the Fleet Commander) of the Western Fleet. His staff appointments include the Director of Naval Operations (DNO), Principal Director of Network Centric Operations (PDNCO), and Principal Director Naval Plans (PDNP).

After his promotion to the Flag Rank, he was appointed as Assistant Chief of Naval Staff (Policy and Plans), Flag Officer Commanding Eastern Fleet, Commandant of the prestigious Indian Naval Academy, Director General of Naval Operations, Chief of Personnel and the Flag Officer Commanding-in-Chief Western Naval Command.

Such diverse range of sea and staff appointments have enabled him to grasp the nuances of plans, operations, personnel and practically every aspect of Indian Navy's functioning.

The Admiral is a graduate of Defence Service Staff College, Wellington, where he was awarded the Thimmaiya Medal for being the best all-round officer. The Admiral attended the Naval Higher Command Course and Naval Command College at the US Naval War College, Newport, Rhode Island, in 2007-08, where he won the Prestigious Robert E. Bateman International Prize.

The Admiral is a recipient of the Param Vishist Seva Medal, Ati Vishist Seva Medal and Nao Sena Medal for devotion to duty.

He is a keen sportsman and avidly follows tennis, badminton, and cricket. The Admiral is a student of International Relations, Military History, and the art and science of Leadership. He is married to Mrs Shashi Tripathi, an artist and homemaker. The couple have a son, Divyam, a practising lawyer, who is married to Tanya, who works in the public health policy domain.

Adm VLADIMIR M.VOROBEV Deputy CinC- Russian Navy

He was born on January 6, 1969 in the family of a naval officer.

In 1990, after graduating from the navigation faculty of the Leninsky Komsomol Higher Naval Diving School, he was sent to the Northern Fleet. During his 11 years of service on nuclear submarines, He rose from Lieutenant engineer of the group to Captain of the $1^{\rm st}$ rank – Commander of the ship.

From 2001 to 2003 he studied at the Naval Academy named after Admiral of the Fleet of the Soviet Union N.G.Kuznetsov in St. Petersburg. Then he returned to the Northern Fleet as Deputy Commander of the unit.

He served as Commander of the nuclear submarine division, Deputy Commander of the submarine squadron, Chief of Staff of the Base, Head of the Combat Training Department of the Northern Fleet and Commander of the White Sea Naval Base. After graduating from the Military Academy of the General Staff of the Armed Forces of the Russian Federation in 2019, he was appointed First Deputy Fleet Commander – Chief of Staff of the Baltic Fleet, and then headed the Headquarters of the Northern Fleet.

In the fall of 2021, he was appointed Deputy Chief of the General Staff of the Russian Armed Forces, and two years later He was appointed Commander of the Baltic Fleet.

From June 2024 to the present, he holds the position of Deputy Commander-in-Chief of the Navy.

He was awarded orders, state and departmental medals. On December 9, 2024, he was awarded the regular military rank of Admiral. Married.

Rear-admiral Lainé was born in 1972 in Montluçon. He joined the French naval academy in 1992. After completion of training deployment on board the helicopter-carrier Jeanne d'Arc, he specialized in surface warfare.

He served notably onboard patrol-boat La Glorieuse based in New-Caledonia French oversea territory, ASW destroyer Jean de Vienne, ASW destroyer Montcalm, helicopter-carrier Jeanne d'Arc and air defence destroyer Forbin.

He was deployed three times onboard aircraft carrier Charles de Gaulle as staff officer and twice as chief of staff of the carrier strike group.

He has commanded the training-ship Tigre, the stealth frigate Surcouf and the air defence destroyer Chevalier Paul.



Prof. Ronán LongDirector, WMU-Sasakawa Global Ocean Institute

Professor Ronán Long is the Director of the WMU-Sasakawa Global Ocean Institute (https://www.wmu.se/goi) at the World Maritime University (WMU) in Malmö, Sweden.

Professor Long leads the WMU-Sasakawa Global Ocean Institute team that engages in interdisciplinary research and is an interface between science, policy, and law to address contemporary challenges in ocean governance and the Law of the Sea. Faculty, staff and students at the Institute undertake evidence-based research, as well as educational and capacitydevelopment training, with a focus on the United Nations Sustainable Development Goals. Particularly Goal 14, Life Below Water, as well as Goal 5 on Gender Equality, Goal 13 on Climate Action and Goal 17 on Partnerships. The Institute's work includes substantive contributions to international processes including the ratification and implementation of the BBNJ Agreement, the UN World Ocean Assessment, the UN Decade of Ocean Science for Sustainable Development (2021-2030), as well as the development of a legally binding instrument on plastic pollution under the auspices of the UN Environment Programme. The research programmes 2024 to 2028 focuses on the future of ocean governance and ways to combat the triple planetary crisis. The Institute also provides support to small island developing states' (SIDS) and coastal least developed countries (LDCs) in their efforts to ratify and implement the BBNJ Agreement. The research explores the establishment of a unified framework to unlock the full potential of ocean technologies and Artificial Intelligence (AI) in observing and monitoring deep ocean ecosystems, as well as gender empowerment and diversity.

Prof. Long is the author/co-editor of more than 15 books and over 100 scholarly articles on oceans law and policy. He read for his PhD at the School of Law Trinity College Dublin, and has been a Senior Visiting Scholar-in-Residence at the University

of California, Berkeley, and a Visiting Scholar at the 'Centre for Oceans Law and Policy' at the University of Virginia. Additionally, Professor Long teaches on the Law of the Sea programme at Harvard Law School, Rhodes Academy Oceans Law and Policy, as well as supervises the United Nations - The Nippon Foundation of Japan Fellowship Programme visiting WMU.

Prior to his academic career, he was a permanent staff member at the European Commission and undertook over 40 missions on behalf of the European Institutions to the Member States of the European Union, the United States of America, Canada, Central America as well as to African countries. During his previous career in the Irish Naval Service, he won an academic prize at Britannia Royal Naval College and held a number of appointments ashore and afloat, including membership of the Navy's elite diving unit.

As a keen yachtsman, he has represented Ireland at the top competitive level in offshore racing. Ronán is passionate about the law of the sea, conservation and global sustainability, as well as the implementation of the 2030 Agenda for Sustainable Development.



RAdm. Brett SonterCommander, JATF Operation Sovereign Borders

Rear Admiral Brett Sonter, Royal Australian Navy, assumed command as Commander Joint Agency Task Force – Operation Sovereign Borders on 10 January 2024.

Rear Admiral Sonter was born in Sydney and joined the Royal Australian Navy in 1990. After three years at the Australian Defence Force Academy, he graduated with a Bachelor of Science Degree from the University of New South Wales. He also holds a Master of Arts (Strategy and Policy) from the University of New South Wales and a Master of Science (Strategy) from the U.S. National Defence University.

His career as a Principal Warfare Officer includes postings in Her Majesty's Australian (HMA) Ships Newcastle, Stuart, and Darwin as the Executive Officer. Highlights of his time at sea have been his Commands of HMA Ships Ballarat, Stuart and Anzac, and as the Commander of the Australian Amphibious Task Group; the later assignment resulting in him being appointed as the Commander of Joint Task Force 635 tasked with providing HADR to Fiji following Tropical Cyclone Winston.

Professor Quentin Hanich leads the Fisheries Governance Research Programme at the Australian National Centre for Ocean Resources and Security (ANCORS), University of Wollongong, where he is a Nippon Foundation Ocean Nexus Research Chair. He has established various international research partnerships focusing on ocean governance and equity, marine conservation, and the sustainable and equitable management of transboundary fisheries. He is particularly interested in strategic research and capacity building projects that strengthen cooperation and consensus building. With this goal in mind, he engages closely with governments, stakeholders and international fora, and develops collaborative studies and capacity building programmes that address current and future ocean governance and policy challenges.

In addition to his roles at the University of Wollongong, Professor Hanich was elected in 2024 to chair the Indian Ocean Tuna Commission's allocation committee. He is also a Principal Investigator in the Nippon Foundation funded Ocean Nexus Programme, a research partner with the Japanese Fisheries Research and Education Agency (FRA), Korean Maritime Institute (KMI), and the Solomon Islands National University. He is also a member of the United Nations Pool of Experts for the World Ocean Assessments #2 and #3.

He lectures and writes on oceans governance, international fisheries, marine conservation, and fisheries development in the Asia Pacific region, and is a regular peer reviewer for numerous globally respected journals. He has assessed PhDs for multiple Universities, and research and development proposals for the Australian Research Council, the World Bank, the Australian Aid Programme, the New Zealand Aid Programme, and the Netherlands Organisation for Scientific Research.

Prof. Hanich has developed and taught undergraduate and post-graduate subjects, post-graduate courses, and professional short courses on international negotiations, fisheries





United Kingdom Maritime Component Commander & Deputy Commander Combined Maritime Forces

Commodore Aldous joined the Royal Navy as a Warfare Officer in 1998 with a Law Degree from Southampton University. Following initial training at BRNC Dartmouth his early career



spanned Officer of the Watch and Navigator appointments in MCMVs, Frigates and Destroyers, including operations off Iraq in 2003. 



On retirement his expertise was secured by the United Nations and performed as an International Consultant to the UNODC on Undersea Cables and Maritime Intelligence.



He is married to Mrs. Sonali Edirisinghe and blessed with two sons 'Venuka' and 'Tharuka.'




Dr. Asantha Senevirathna FDSS, KDU
